Muncho Privacy Policy

Effective date: October 12, 2023

At Muncho, safeguarding your privacy is our priority. Familiarize yourself with the details below to understand our approach to handling your personal data. By engaging with our Services, you recognize and agree to the terms described in this Privacy Policy, granting us permission to gather, process, and distribute your information as specified.

Always note that when using Muncho's Services, you're also bound by our Terms of Use, which includes this Privacy Policy. Any undefined terms in this Policy are clarified in our Terms of Use.

Overview

This Privacy Policy details our handling of Personal Data obtained when you engage with our Services. Here, "Personal Data" refers to any information associated with or identifying an individual, often termed as "personally identifiable information" or "personal information" under relevant data protection laws and guidelines. The policies of entities not owned or directed by us, or individuals not under our supervision, are not included within this Privacy Policy.

How We Obtain Your Personal Data

We gather your Personal Data from the following sources:

Directly from You:

- · When you voluntarily share such information with us, and
- As a result of your engagement with our Services when certain Personal Data is automatically recorded.

From Third Parties ("Third Parties") who share information about you with us, such as:

- Service providers. For instance, we may collaborate with analytics providers to understand your interactions with our Services, or other third parties might aid us in offering customer support.
- Linked social media. If you link your social media accounts with our Services or log in through a third-party platform, be aware that some details or content from those accounts might be integrated into your account with us.
- Marketing allies. Some of our service providers who support our marketing and promotional endeavors share insights about your interactions with our web platforms, apps, products, services, advertisements, or communications.

Types of Personal Data We Gather

E.	Biometric information Examples: Genetic, physiological, behavioral, and biological characteristics or identifying activity patterns, such as fingerprints, faceprints, and voiceprints, iris or retina scans, keystroke, gait, or other physical patterns, and sleep, health or exercise data. F.	Internet or other similar network activity information Examples: Browsing history, search history, or information on a consumer's interaction with a website, application or advertisement.	We may gather details on a user's interactions with Muncho's offerings, such as browsing, purchasing, and search histories, as well as any other engagements with our websites or applications. However, we do not capture information related to or stemming from a user's interactions with products from other companies.
G.	Geolocation data Examples: Physical location or movements.	We collect your physical location while you are using the application and websites via GPS and IP address
Н.	Sensory data Examples: Audio, electronic, visual, thermal, olfactory or similar information.	We do not collect this category of Personal Data.

L.	Age or date of birth	We may collect your date of birth and age if you choose to give it to us.
М.	Device Data	We might gather information related to the devices you use to access our services. This includes details such as hardware models,

		unique device identifiers of IP addresses, operating system types and versions, software, language preferences, advertising IDs, data on device movements, and cellular network information.
N.	Communications Data	Users can interact with each other and with Muncho via our mobile apps and websites. For instance, we facilitate communication between users, delivery personnel, and those receiving orders, allowing them to call, text, or share files without revealing their phone numbers to one another. To offer this feature, Muncho captures certain details about these interactions, such as the timing and content of the communications. We might utilize this data for customer assistance (including settling user disputes), ensuring safety and security, enhancing our services, and for analytical purposes.
0.	Contacts List	With user consent: We transfer users' contact details to Muncho's servers, allowing users to identify and engage with friends who are already Muncho users when the app is active.
P.	Camera	With the user's consent, we may access the device's camera to scan and store credit card details for transactions. The camera can also be utilized to take profile images.
Q.	User Content	When users reach out to Muncho's customer support, submit ratings or praises for fellow users, restaurants, or merchants, or contact Muncho in any capacity, we gather the information they provide. This could encompass feedback, images, and any audio or video recordings shared by users for customer support purposes. Additionally, we collect metadata associated with the way you communicate with Muncho.

More About How We Collect Your Personal Data

Automated Data Collection

Our Services employ cookies and related technologies like pixel tags, web beacons, and JavaScript, collectively referred to as "Cookies." These allow our servers to identify your browser, track your interaction with our Services, analyze user patterns, and refine our offerings.

Cookies are tiny data bits, mostly text, stored on your device when you access our Services. We might also integrate the data we gather with information from third parties, which might have placed their own Cookies on your devices. Presently, our use of Cookies means we do not recognize "Do Not Track" browser requests.

We deploy various Cookies:

- 1. Essential Cookies: Crucial for certain features or services you request. For instance, they allow access to secure parts of our services. Disabling them might limit some functionalities.
- 2. Functional Cookies: Remember your Service-related choices and settings. They let us tailor our content, remember preferences like language, and recognize return users.
- 3. Performance/Analytical Cookies: Help us understand user behavior on our Services, like page views or visitor numbers. They also measure our ad campaign efficiency. We might use tools like Mixpanel or Looker for device metrics and analytics.
- 4. Retargeting/Advertising Cookies: Track online activity to provide more relevant advertisements. More details are in the section "Information about Interest-Based Advertisements."

You can manage Cookie preferences in your browser's settings. Most browsers let you disable Cookies or decide on their acceptance. Deleting Cookies might mean manually resetting some preferences during subsequent visits, potentially hindering some functionalities.

About Interest-Based Advertisements:

We might display advertisements and permit third-party advertising networks, including agencies, technology vendors, and research entities, to showcase ads via our Services. We leverage your Personal Data to improve, enhance, comprehend, personalize, and administer our Services.

Your Personal Data aids us in:

Handling and Disclosure of Your Personal Data

Business-Related Disclosures of Personal Data

We collect and upload users' Phone Number information via Unionpay SDK.

For specific operational purposes, we share your Personal Data with service providers and relevant entities:

- Auditing linked to ongoing interactions and related operations, such as counting unique ad viewers, validating ad placements, ensuring ad impression quality, and ensuring adherence to guidelines and standards.
- Detecting and counteracting security breaches, malicious or deceptive actions, and pursuing perpetrators of such activities.
- Debugging to pinpoint and rectify issues affecting the intended functionality.
- Brief, immediate usage of Personal Data, ensuring it's not employed by third parties for constructing consumer profiles or modifying your user experience beyond the current transaction.
- Delivering services, including account management, order processing, customer support, payment processing, marketing and advertising services, analytics, and other similar functions.
- Engaging in research for tech enhancement and demonstrations.
- Activities that ensure or improve the quality or safety of our services or devices that we own, have produced for us, or oversee.

Protecting and Storing Your Personal Data

We prioritize safeguarding your Personal Data against unauthorized access, usage, and disclosure by implementing suitable physical, technological, organizational, and administrative security protocols based on the nature of the Personal Data and our processing methods. It's essential that you also contribute to the security of your data, such as by choosing strong passwords, limiting device and browser access, and ensuring you log out after using your

account. While we are committed to data protection, complete online data security isn't guaranteed. Except where mandated by law, we aren't liable for any unintended disclosure, theft, loss, or damage to your information.

Children's Personal Data

As highlighted in our Terms of Use, we intentionally avoid collecting Personal Data from children under 16. If you're below this age, please refrain from registering or using our Services or sending any Personal Data. If we become aware of collecting data from someone under 16, we'll promptly delete it. If you suspect a child under 16 has shared data with us, please inform us at info@muncho.io.

Rights of California Residents

Access

Deletion

You can request the deletion of your Personal Data. Under the CCPA, exceptions exist: for instance, retaining your Personal Data might be necessary for service provision or to finalize a requested action. If such exceptions apply, we might refuse your deletion request.

Exercising Your Rights

For exercising the above rights, your request should: (1) verify your identity based on the collected Personal Data, and (2) sufficiently detail your request. A request meeting these conditions is deemed a "Valid Request." We might not address incomplete requests. Personal

Data from a Valid Request will only verify your identity and address your request. An account isn't necessary for a Valid Request.

We aim to address Valid Requests within 45 days of receipt. While typically free, excessive or unfounded Valid Requests might incur fees. If applicable, we'll inform you of the fee and its justification before addressing your request.

Opting Out of Personal Data Sales

You reserve the right to decline the sale of your Personal Data.

Commitment to Fair Practices

Exercising your rights under the CCPA won't subject you to discriminatory treatment by us. Specifically:

- We won't offer you a diminished quality of goods or services.

Nevertheless, in compliance with data privacy laws (including the CCPA), we might offer varied Service tiers, which may have differential pricing, quality, or rates. These differences correspond to the value of the Personal Data we obtain from you.
